**MOH/ORD/005/17: TENDER FOR THE SUPPLY AND DELIVERY OF INDOOR RESIDUAL SPRAYING (IRS) COMMODITIES FOR THE 2017 SPRAYING CAMPAIGN.**

1. The Government of the Republic of Zambia has released funds to the Ministry of Health and it intends to apply part of the proceeds to payments under the contract for the supply and delivery of **Indoor Residual Spraying (IRS) Commodities for the 2017 Spraying Campaign.**
2. Bidding will be conducted through the **Open National Bidding** Procedure specified in the Public Procurement Act of 2008 and the Public Procurement Regulations of 2011 and is open to all eligible and interested bidders as defined in the Bidding Documents.
3. The Ministry of Health now invites sealed bids from eligible and qualified bidders for the supply and delivery of Indoor Residual Spraying Commodities for 2017 Spraying Campaign.
4. A complete set of bidding documents may be purchased from the Ministry of Health, upon payment of a non-refundable fee of **ZMW1, 000.00** or its equivalent in any freely convertible currency at the prevailing exchange rate, in cash or Bank certified Cheque .
5. The bidders may obtain further information from the Ministry of Health and inspect the Bidding Documents at the address given below from 08:00 hours to 13:00 hours and from 14:00 hours to 17:00 hours. Monday to Friday. A complete set of Bidding Documents in English may be obtained from the Office of Head Procurement Unit.
6. Bids must be delivered to and placed in the tender box at the address below on or before 10:00 hour's local time on Friday, **28<sup>th</sup> April, 2017**. Bids must be appropriately bound, sealed and labelled. Electronic bidding will not be permitted. Late bids will be rejected.
7. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person at the address below immediately after 10:00 hours local time on Friday, **28<sup>th</sup> April, 2017**. All bids must be accompanied by a **2% Bid Security of the bid amount**.
